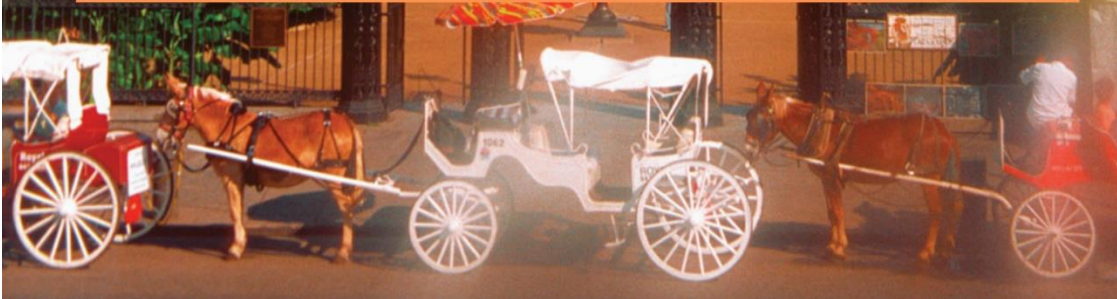

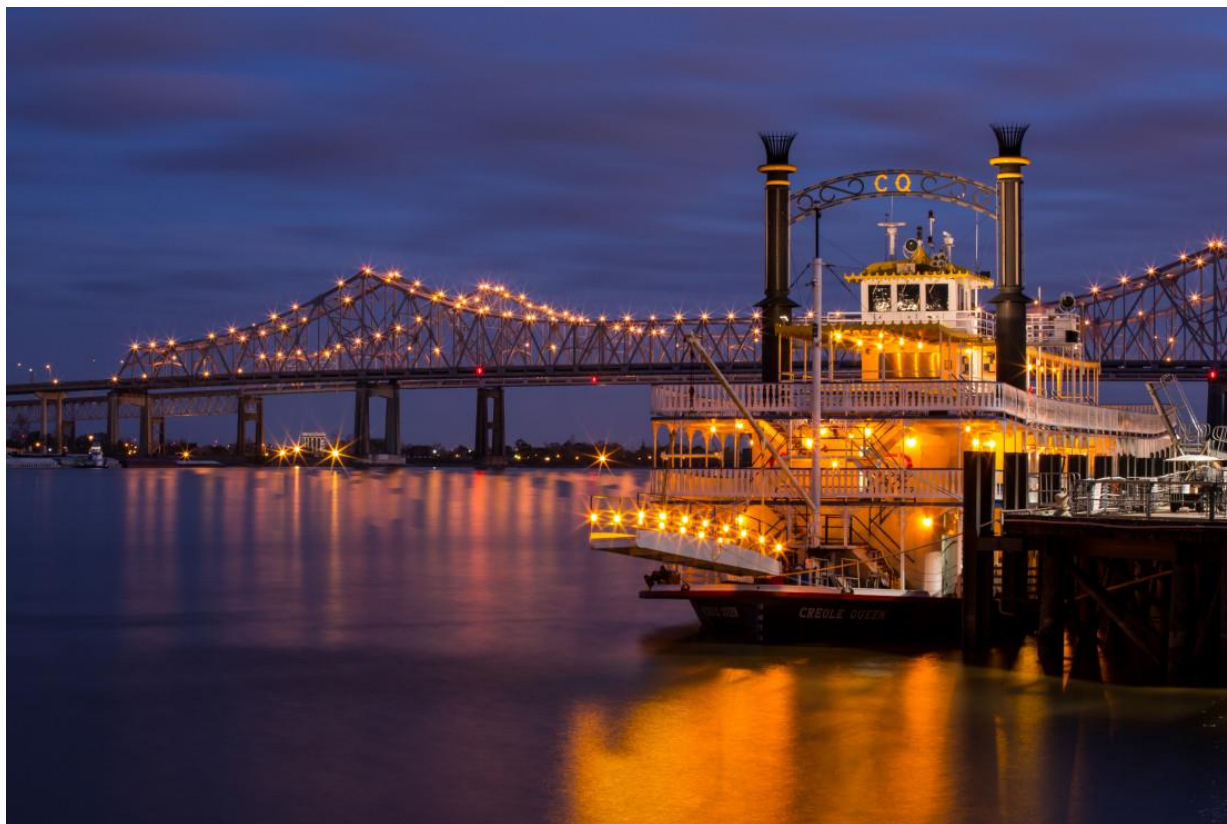

Keynote Speaker – Commissioner Jim Donelon



Jim Donelon has served as Commissioner of Insurance for the state of Louisiana for more than 15 years. He was first appointed as Insurance Commissioner in February 2006 when the seat was vacated by the incumbent. He was later elected to fill the unexpired term in 2006 and has been re-elected to four consecutive full terms.

Stephen Flynn is supervising professional at Riverland Surveying Company and is responsible for the surveying and mapping activities of the firm. Serving on the Louisiana Society of Professional Surveyors for many years, he was the state president in 2012 and received the Surveyor's Excellence Award in 2013.
