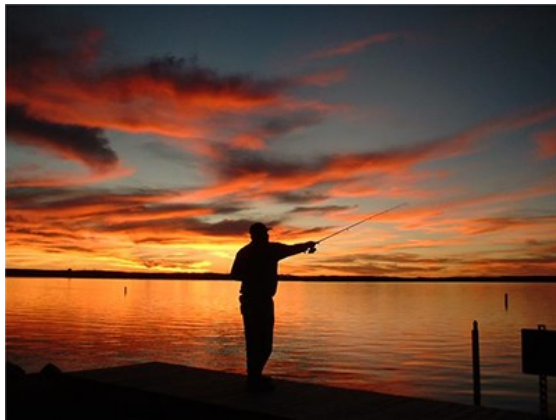
## Hotel Accommodations
